



Webinity - Partnership Agreement

As an authorized Partner of Webinity, you agree to abide by the terms and conditions of this Agreement. Please read this Agreement carefully before using your referral link to promote Webinity. Usage of your referral link will result in you becoming our Partner and will mean that you have read and accepted the terms and conditions of this Partnership Agreement.

Payouts

All payouts are going to be executed through PayPal unless we've made a different agreement with specific Partners.

Partners will receive 20% commission of the monthly subscription of the referral for as long as the referral's subscription stays active. Commissions are only earned on successful transactions. Any transactions that result in chargebacks or refunds will not be paid out.

We reserve the right to hold back payouts for as long as necessary in the event Webinity wishes to review specific referrals, commissions, or anything else related to your account that will raise our concern.

Webinity reserves the right to end the partnership program at any time. In the event of the program's closure, no future commissions (except these already earned) will be paid going forward.

Removal From Our Partnership Program

Webinity reserves the right to remove Partners at our sole discretion. While we can remove Partners at any time and for any reason, most removals will be because of one of the following reasons:

- Bidding on PPC keywords that were not approved by our team, and in direct conflict with our own advertising.
- Using strategies that we deem as "spammy" or otherwise illegal.
- Not disclosing your partner relationship with your audience with reasonable means.
- Disguising your partner link as a coupon or deal link.
- Posting your link on coupon & deal websites.

Coupon And Deal Sites

We do not allow Partners marketing on coupon or deal sites where the partner link is being disguised as a coupon or deal. We reserve the right to blacklist specific domains of

coupon sites and disqualify any traffic, signups, or commissions that are generated from these sites.

Pay Per Click

Partners must get written permission before running PPC campaigns with keywords that might compete with Webinity PPC campaigns. You can simply reach out to our team for permission to run PPC campaigns and include the keywords you intend to bid on. We do not allow bidding on Webinity-branded keywords.

Liability

Webinity is not liable for indirect or accidental damages (loss of revenue, commissions) due to Partner tracking failures, loss of database files, or any results of intents of harm to the Program and/or to our websites.

We do not make any expressed or implied warranties with respect to the Program and/or the memberships or products sold by Webinity. We make no claim that the operation of the Program and/or our websites will be error-free, and we will not be liable for any interruptions or errors.

Terms of the Agreement

The terms of this Agreement begin once you're accepted in the program and end once your account is terminated. Webinity reserves the right to modify the terms and conditions of this Agreement at any time. By continuing to participate in our partnership program, you accept any changes to our terms and conditions.
